To keep all buildings unceasingly insured during the term of the mortgage, against loss by fire and such other hazards in such company or companies and in such an amount as shall be satisfactory to the mortgagee: to deposit with the mortgage all such policies with receipts showing payment in full of all premiums: all such insurance shall be made payable to the mortgagee; insurance shall be kept in force by the mortgager in case of forcelosure until the period of redemption expires;
