KNOW ALL MEN BY THESE PRESENTS, That

hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of KLAMATH and State of Oregon, described as follows, to-wit:

(Easterly Portion) A tract of land situated in Lot 13, Block 4, Pleasant View Tracts, Klamath County, Oregon, a duly recorded subdivision, being more particularly described as the easterly 75 feet of said Lot 13, containing 7125 square feet (0.16 acres).

grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 5,000.00
