KNOW ALL MEN BY THESE PRESENTS, That FURMAN TUPPER

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by TERRY BLACKBURN and LINDA BLACKBURN, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

The following described real property in BAILEY TRACTS, more particularly described as follows:

All of Lot 27 and that part of Lot 28 in said BAILEY TRACTS, commencing at the Northwest corner of said Lot 27 above described; thence North along the Westerly line of Lot 28 a distance of 42 feet; thence Easterly parallel to the Northerly line of said Lot 27, 107 feet; thence at right angles South a distance of 28 1/2 feet; thence Easterly parallel to the Northerly line of said Lot 27 a distance of 198 1/2 feet, more or less, to the Easterly line of said Lot 28; thence Southerly along the Easterly line of said Lot 28 to the Northeasterly corner of said Lot 27; thence Westerly along the said Northerly line of said Lot 27, 304.28 feet, more or less, to the place of beginning.

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever. And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$30,000.00. However, the actual consideration consists of or includes other property or value given or promised which is the whole consideration (indicate which) (The sentence between the symbols ©, if not applicable, should be deleted.
