Buyer has purchased the property solely upon Buyer's own personal inspection and in its present actual condition and has not relied upon any warranties or representations made by the Seller, or by any agent of the Seller.

Seller warrants and represents to Buyer that Seller owns the property in fee simple free from all encumbrances Sexpept subject to restrictions in the patent from the United States Government and the State of Oregon, restrictions in the dedication of the plat, the regulations and rules of Klamath County, and restrictions of record in the official files Payment of Seller's Liens:

Seller, warrants that Seller will make all payments on any contracts, mortgages, liens, judgments or other encumbrances outstanding which Seller has incurred during or prior to this contract as the same fall due except this years real property takes if this agreement is made after June 30th and before November 15th. Buyer agrees to Purch se Payment of Taxes and other Liens:

Buyer will pay all liens which Buyer permits or which may be lawfully imposed upon the property promptly and before the same or any part thereof become past due. In the event that the Buyer shall allow the taxes or other assessments upon the property to become delinquent or shall fail to pay any lien or liens imposed or permitted upon the property as they become due, the Seller without obligation to do so, shall have the right to pay the amount due and to add said amount to the contract balance, to bear interest at the rate provided barein Removal of Improvements:

No improvements placed on the property shall be removed before this contract is paid in full. Use of Property:

Buyer agrees not to abuse, misuse or waste the property, real or personal, described in this contract and to maintain the property in good condition,

Seller warrants and represents to Buyer that Seller has obtained preliminary subsurface sewage disposal approval. Seller further warrants to Buyer that if during the first year after this purchase Buyer cannot obtain an individual approval on said lot Seller will make full refund of all monies to Buyer,

Buyer's Deed:

When Buyer pays and performs this contract in full, Seller shall give to Buyer, or Buyer's heirs or assigns, a good sufficient warranty deed conveying good and merchantable title in tee simple, free and clear of encumbrances excepting fleds and encumbrances stiffered or permitted by the Buyer or Buyer's heirs or assigns and subject to restrictions in the patent from the United States Government and the State of Oregon, restrictions in the dedication of the State of Oregon, restrictions in the dedication of the State of Oregon. of the plat, the requiations and rules of Klamah County, and restrictions of record in the official files of the County of the plan, the teaching free as is a common of Clerk of Klamath County free as is a common of the control of

Time is of the essence of this contract and Buyer agrees to promptly make all payments when due and to fully and

promptly perform all other obligations of this contract. In the event of default by the Buyer upon any of the terms and conditions contained herein and after 30 days written notice of default by Seller:

(1) Seller may declare this contract terminated and at an end and upon such termination, all of Buyer's right, title and interest in and to the described property shall immediately dease. Seller shall be entitled to the immediate procession of the described property, may foreign enter and take procession of the described property. diate possession of the described property; may forcibly enter and take possession of said property removing Buyer and his clients; and all payments theretofore made by Buyer to Soller and all improvements or fixtures placed on the described property shall be retained by the Seller as liquidated damages, or in the alternative.

(2) Seller may, at his option, declare the entire unpaid principal balance of the purchase price with interest the sent results and payable, and forcelose this contract by strict forcetosure in equity, and upon the filling thereon at once due and payable, and foreclose this contract by strict foreclosure in equity, and upon the filling of such suit all of the Buyer's right, title and interest in and to the above-described property shall immediately cease. Seller shall be entitled to the immediate possession of said property; may forcibly enter and take possession of said property removing Buyer and his effects and all payments therefore made by Buyer to Seller and all improvements or fixtures placed on the described real property shall be retained by the Seller as liquidated damages. Such right to possession in the Seller shall not be deemed inconsistent with the suit for strict foreglosure but shall bein furtherence thereof, and in the event Buyer shall refuse to deliver possession upon the filing of such suit. Buyer, by the execution of this contract, consents to the entry of an interlocutory order granting possession of the premises to the Seller immediately upon the filing of any sunt for strict foreclosure without the necessity of the Seller posting a bond or having a receiver appointed, or in the

anernative.

(3) Seller shall have the right to declare the entire unpaid principal balance of the purchase price with interest thereon at once due and payable, and in such event. Seller may either bring an action at law for the balance due, thereby waiving the security, only the alternative, may tile suit in equity for such unpaid balance of principal and interest and have the property sold at judicial sale with the proceeds thereof applied to the court costs of such suits, attorney's fees, and the balance due Seller, and may recover a deficiency judgment against the Buyer for any ungaid balance remaining on this contract.

(4) In addition to the aforementioned remedies, Seller shall have any and all other remedies under the law. Payment of Court Cost:

If suit or action is instituted to enforce any of this contract, the prevailing party shall be entitled to such sums as the court may adjudge reasonable at attorney's fees in said suit or action in any court including any appellate court in addition to costs and disbursements provided by statute. Prevailing party shall also recover cost of title report.

The parties agree to that failure by either party at any time to require performance of any provision of this contract shall in no way affect the right to enforce that provision or be held a waiver of any subsequent breach of any such
