The hearing was then closed, and based upon the evidence submitted at the hearing, the Hearings Officer made the following Findings of Fact:

FINDINGS OF FACT:

1. The site is adequate in size and shape to

 accommodate the said use, and does fit in with the surrounding area, which is shown by the fact that there are several other mobile homes already in the area.

- 2. The site does relate to streets and highways adequately to carry the traffic which will be generated by the proposed use.
- 3. The proposed use will have no adverse affect on the other property owners.
- 4. The Conditional Use Permit request is consistent with the LCDC Goals.
- 5. The granting of this Conditional Use Permit will be subject to the following conditions: 1. The Applicant shall obtain DEO approval for the use of the mobile home. 2. The Applicant must actually connect the residences, so that there are not two residences on the property. 3. The Applicant must meet the setback requirements for the zone.

The Hearings Officer, based on the foregoing Findings of Fact, accordingly orders as follows:

That real property described as the

"Township 28S, Range 8, East of the Willamette Meridian, Section 19, Tax Lot 17-3-5, Lot 11, North Beaver Marsh, Klamath County, Oregon"

is hereby granted a Conditional Use Permit in accordance with the terms of the Klamath County Ordinance No. 35 and henceforth will be allowed the placement of a mobile home on the subject property subject to the above-mentioned conditions. The granting of this permit does not allow a use which is not authorized (continued on Page 3)
