A GENERAL ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 6223 TO CORRECT AN ERROR IN THE LEGAL DESCRIPTION OF THE TERRITORY ANNEXED TO THE CITY OF KLAMATH FALLS, OREGON, AND DECLARING AN EMERGENCY.

WHEREAS, an error was discovered in the legal description contained in Section 1 of Ordinance No. 6223; and,

WHEREAS, the Common Council of the City of Klamath Falls wishes to correct said error in order to conform the legal description to match the area intended to be annexed; now, therefore,

THE CITY OF KLAMATH FALLS ORDAINS AS FOLLOWS:

Section 1.

Section 1 of Ordinance No. 6223 is hereby amended to read as follows:

The following described contiguous territory is hereby proclaimed to be annexed to the City of Klamath Falls:

Township 38 South, Range 9 East of the Willamette Meridian.

- Section 22 - SE $\frac{1}{4}$ NE $\frac{1}{4}$, E $\frac{1}{2}$ SE $\frac{1}{4}$
- Section 23 - S $\frac{1}{2}$ NW $\frac{1}{4}$, SW $\frac{1}{4}$ NE $\frac{1}{4}$, S $\frac{1}{2}$ SW $\frac{1}{4}$, NW $\frac{1}{4}$ SW $\frac{1}{4}$, SE $\frac{1}{4}$
- Section 25 - W $\frac{1}{2}$, W $\frac{1}{2}$ SE $\frac{1}{4}$
- Section 26 - E $\frac{1}{2}$, NW $\frac{1}{4}$, E $\frac{1}{2}$ SW $\frac{1}{4}$, E $\frac{1}{2}$ W $\frac{1}{2}$ SW $\frac{1}{4}$
- Section 27 - E $\frac{1}{2}$ NE $\frac{1}{4}$
- Section 35 - N $\frac{1}{2}$ NE $\frac{1}{4}$, SE $\frac{1}{4}$ NE $\frac{1}{4}$
- Section 36 - NW $\frac{1}{4}$, W $\frac{1}{2}$ NE $\frac{1}{4}$, SE $\frac{1}{4}$ NE $\frac{1}{4}$, and all that land in the S $\frac{1}{2}$ lying easterly of the Second Addition to Moyina and Tract 1003 Third Addition to Moyina, both in Klamath County, Oregon, according to the official plats thereof on file in the office of the County Clerk of Klamath County, Oregon.

EXCEPTING: That tract of land in Sections 22 and 23 described as follows: Beginning at a point from which the north-west corner of said Section 23 bears N11°01'00"W 4374.62 feet; thence N67°11'54"W to the west line of the E $\frac{1}{2}$ E $\frac{1}{2}$ of said Section 22; thence northerly along said line to the northwest corner of the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of said Section 22; thence Easterly along the north line of the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of said Section 22 and the north line of the SW $\frac{1}{4}$ NW $\frac{1}{4}$ of said Section 23 to a point that bears North of the point of beginning; thence South to the point of beginning; ALSO EXCEPTING the tracts of land described in Deed Volume M74 at page 10332 and In Deed Volume M74 at page 4136, on file in the office of the County Clerk of Klamath County, Oregon.

Section 2.

This ordinance being deemed necessary for the immediate preservation of public peace, health, and safety of the City of Klamath Falls, Oregon, an emergency is hereby declared in the case of this Ordinance, and it shall be in full force and effect immediately upon its passage by the City Council and its approval by the Mayor.
