9 This matter coming on for hearing
10 at this time, petitioner appearing in person
11 and by and through her attorney, Gary L. Hill, and the respondent appearing not,
12 and the default of the respondent having been entered and noted of record;

13 The Court finding that there exist irreconcilable differences between
14 the parties, causing an irremediable breakdown of the marriage.

15 It appearing to the Court that an order having heretofore been entered
16 waiving the remainder of the ninety-day waiting period provided for under ORS 107.065,
17 and the reasons having been given by the petitioner for said waiver being to avoid
18 further stress and strain on the petitioner and the minor child of the parties;

19 It further appearing to the Court and the Court finding that the parties
20 were married on June 27, 1972, and that one child has been born issue of the marriage,
21 to-wit: Anthony Alan, born September 21, 1975.

22 NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED that:

23 1. The marriage of the parties is hereby dissolved and said dissolution
24 is finally effective on the 26 day of September, 1977.

25 2. Petitioner be, and she hereby is, awarded the care, custody and control
26 of the minor child of the parties, subject to the right of reasonable visitation
27 by respondent.

28 3. Respondent pay to petitioner, through the Clerk of the above-entitled
29 Court, the sum of One Hundred and no/100 Dollars (\$100.00) per month for the care,
30 support and maintenance of said minor child. Said payments are to be made in equal
31 semi-monthly installments of Fifty and no/100 Dollars (\$50.00) each on or before
32 the 5th and 20th days of each month, commencing August 5, 1977.

33 4. Petitioner be, and she hereby is, allowed to claim the said minor child

1 as an income tax exemption.

2 5. Petitioner be, and she hereby is, awarded the real property of the
3 parties located at 2118 N. E. Freemont, Roseburg, Oregon, which is more particularly
described as follows, to-wit:

4 Lots 13 and 14, Block 36, KINNEY'S IMPROVED PLAT
5 to the City of Roseburg, Douglas County, Oregon;

6 and is required to assume and pay the encumbrances thereon, saving respondent harmless
7 from any claims therefor.

8 6. Petitioner be, and she hereby is, awarded the real property of the
9 parties located at Chiloquin, Oregon, which is more particularly described as follows,
to-wit:

10 Lots 5 and 6 of the original Town of Chiloquin, Klamath
County, Oregon.

11 7. Petitioner be, and she hereby is, awarded the miscellaneous household
12 furniture, fixtures and appliances, freezer and 1969 Dodge pickup, serial number
1287093611, of the parties, and is required to assume and pay the encumbrances thereon,
13 saving respondent harmless from any claims therefor.

14 8. Respondent be, and he hereby is, awarded the 1971 Subaru, serial number
A14L202251, of the parties, and is required to assume and pay the encumbrance thereon,
15 saving petitioner harmless from any claims therefor.

16 9. Petitioner be, and she hereby is, required to assume and pay the obli-
gation of the parties owing to Montgomery Ward, saving respondent harmless from any
17 claims therefor.

18 10. Respondent be, and he hereby is, required to assume and pay the obliga-
tions of the parties owing to St. Vincent's Hospital, Stillwater Hospital, Billings
Clinic and miscellaneous medical bills incurred prior to June 10, 1977, saving peti-
19 tioner harmless from any claims therefor.


