ASSIGNMENT OF CONTRACT

KNOW ALL MEN BY THESE PRESENTS, that LARRY PHILYAW and PAT PHILYAW, husband and wife, Assignors, for the consideration hereafter stated, do by these presents bargain, sell, transfer and assign unto RICHARD A. LINDGREN and MIRIAM LINDGREN, husband and wife, Assignees, all of Assignors' right, title and interest in and to that certain Agreement dated October 30, 1978 and recorded November 6, 1978 in Vol. M-78 at page 25000 of Klamath County, Oregon, Deed Records, wherein Williams C. Williams and Anne D. Williams, husband and wife, agreed to sell and the Assignors agreed to purchase the property in Klamath County, Oregon, described as follows, to-wit:

A portion of Lot 1, Block 3, Tract 1091, Lynnewood, in the City of Klamath Falls, Klamath County, Oregon, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, together with the vacated portion of Arrowhead Road (30 feet wide) adjoining, more particularly described as follows: Beginning at a point on the Westerly line of said Lot 1, said point being North 18°21'42" East a distance of 73.71 feet from the Southwest corner of said Lot 1; thence North 18°21'42" East along the West line of Lot 1, a distance of 83.87 feet to the beginning of a tangent curve concave to the Southeast and having a radius of 134.26 feet; thence Northeasterly along said curve a distance of 51.57 feet (chord of said curve bears North 29°22'00" East, with a length of 51.26 feet); thence North 40°22'18" East a distance of 73.56 feet; thence South 00°05'51" West, along a line parallel with and 30 feet distant from the East line of Block 3, a distance of 180.48 feet; thence North 89°54'09" West a distance of 98.90 feet, to the point of beginning. Containing 0.25 acre, more or less.

The true and actual consideration paid for this Transfer is \$17,000.00 of which \$9,806.15 is paid in cash and \$7,193.85 is paid by Assignees hereby assuming and agreeing to pay and perform said Agreement hereby assigned according to its terms and to hold the Assignors harmless therefrom.

Assignors further in consideration of the foregoing convey unto the Assignees all of Assignors' right, title, estate and interest in said property subject to the terms of said Agreement.

Assignors further covenant and agree to and with the Assignees that said Agreement is a good, valid and existing contract; that there remains unpaid thereon no more than the sum of \$7,193.85 with interest thereon at the rate of 9-1/4% per annum from February 17, 1979; that said Contract is not in default and that Assignors have good right to assign the same as aforesaid.

TO HAVE AND TO HOLD the same unto the Assignees.
