KNOW ALL MEN BY THESE PRESENTS, That CHARLES EUGENE WEBB

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by CHARLES EUGENE WEBB, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of KLAMATH and State of Oregon, described as follows, to-wit:

The Southerly 220 feet of the $W\frac{1}{2}SW\frac{1}{4}SW\frac{1}{4}NW\frac{1}{4}$ of Section 21, Township 40 South, Range 8 East of the Willamette Meridian, in Klamath County, Oregon.

RESERVING THEREFORM an easement over the Easterly 30 feet of the above described parcel.

TOGETHER WITH a $1/3$ undivided interest in the Northerly 30 feet of the $E\frac{1}{2}SW\frac{1}{4}SW\frac{1}{4}NW\frac{1}{4}$ and the Northerly 30 feet of the $SE\frac{1}{4}SW\frac{1}{4}NW\frac{1}{4}$ that lies Westerly of the Keno-Worden Road, and the Easterly 30 feet of the $W\frac{1}{2}SW\frac{1}{4}SW\frac{1}{4}NW\frac{1}{4}$, all in said Section 21.

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
