The undersigned subordinator and owner agrees as follows:

1. Round Lake Estates Limited, a California Limited Partnership, referred to herein as "Co-subordinator", is the owner and holder of a trust deed dated 8/25, 1978, which was recorded in Volume M 78, page 19265, Mortgage Records, Klamath County, Oregon.

2. Patrick J. Oliver, referred to herein as "Owner" is the owner of all of the real property described in the mortgage and identified below in paragraph 3.

3. Rainer Credit Company, referred to herein as "Lender", is the owner and holder of a mortgage dated March 15, 1979, to be recorded concurrently herewith.

4. In consideration of the subordination agreement attached to the trust deed referred to in paragraph 1 above, the subordinator does hereby unconditionally subordinate the lien of its trust deed identified in paragraph 1 to the lien of lender's mortgage identified in paragraph 3 above, to which the lien of the subordinator's trust deed, identified in paragraph 1 above, will be subordinated to a maximum principal of \$200,000, which is to be repaid in 3 years including principal and interest.

5. The heirs, administrators, assigns and successors in interest of the subordinators to be bound by this agreement.
