Grantor covenants not to place or permit to be placed or maintained any buildings or flammable materials within 5 (five) feet of the center line of said easement Grantor further covenants that no digging will be done or permitted upon said easement which will in any manner disturb the solidity of Grantee's communication facilities or feet of the center line of said easement. unearth any portion thereof; and that no blasting or discharge of any explosives will be permitted within $\frac{5}{(five)}$ feet of the center line of said easement.

Grantor reserves the right to use the property for agricultural purposes not inconsistent with the rights granted Grantee.

Grantee, its contractors, agents, employees and servants shall at all times have the right of ingress to and egress from said easement with the specific understanding that Grantee shall be responsible for any property damage suffered by Grantor caused by Grantee's exercise of the rights herein granted.

Grantee is also granted the right from time to time to increase or decrease the size, weight or number and to change the type or add to any of said communication facilities which may be constructed or installed in, upon or under the easement hereby granted.

The rights, conditions and provisions of this easement shall imure to the benefit of and be binding upon the heirs, executors, administrators, successors and assigns of the respective parties hereto.
