

KNOW ALL MEN BY THESE PRESENTS, That OPAL C. WATERS and FAY A. WATERS, her husband, hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by LOUIS F. PERDRIAU and FRANCES H. PERDRIAU, husband and wife, as tenants by the entirety, an undivided one-half interest and BOBBY ALLEN DORTCH and MARY HELEN DORTCH busband and wife, as tenants by the entirety. DORTCH, husband and wife, as tenants by the entirety, an undivided one-half interest, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows: to-wit: The $NW_{\frac{1}{4}}$ of $SE_{\frac{1}{4}}$ and Lot 8 in Section 31, Township 39 South,

Range 10 East of the Willamette Meridian, Klamath County,

That portion of Lot 7 and the SW_{4}^{1} of SE_{4}^{1} lying within the following boundaries, to-wit:

Beginning at the Northeast corner of the SW_{4}^{1} of SE_{4}^{1} ; thence

West on subdivision line to the meander line of the East side of Lost River; thence

following said meander line down stream to a point 7 chains 68 liks North of the South section line; thence

Northeasterly on a straight line to a point 4.40 chains South of the place of beginning; thence

North 4.40 chains to the place of beginning, all in Section 31, Township 39 South, Range 10 East of the Willamette Meridian.

The NE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 31, Also beginning at the Northeast corner of the SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of said Section 31; thence

West 20 chains to stone; thence

South 4 chains and 40 links to stone; thence

Northeasterly to the place of beginning, in Township 39 South, Range 10 East of the Willamette Meridian, also that part of the NW4 of SW4 of Section 32, Township 39 South, Range 10 East of the Willamette Meridian lying West of the Hill Road.

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances, except as above set forth, and that grantor will warrant and forever defend the above granted premises and every part and parcel thereof against the lawful claims and demands of all encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars is \$60,000.00. However, the actual consideration consists of or includes other property or value given or promised which is the whole consideration—\$10,000.00 cash and \$50,000.00 on contract.

In construing this deed and where the context so requires, the singular includes the plural.
