KNOW ALL MEN BY THESE PRESENTS, That

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by Steve Gelhardt and Judy Gelhardt, husband and wife, as to an undivided one-half interest, hereinafter called half interest and Cheryl Swetland as to an undivided one-half interest, the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantees, heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit: The Northerly 79 feet of Lots 30, 31 and 32, Block 7, INDUSTRIAL ADDITION TO THE CITY OF KLAMATH FALLS, in the County of Klamath, State of Oregon.

Subject, however, to the following:

1. Taxes for the year 1978-1979 are now a lien but not yet payable.
2. Regulations, including levies, liens and utility assessments of the City of Klamath Falls.
