MODIFICATION OF MORTGAGE

THIS AGREEMENT, made and entered into this 14th day of March, 1979, by and between WARREN GENE ADAMS, a married man,

hereinafter called the "Mortgagor", and WESTERN BANK, Coos Bay, Oregon, an Oregon banking corporation, herein after called the "Mortgagee".

WITNESSETH: On or about the 3rd day of March, 1978, the Mortgagor(s) did make, execute and deliver to the Mortgagee their certain promissory note in the sum of \$ 11,349.36, payable in monthly installments with interest at the rate of 12.41 % per annum. For the purpose of securing the payment of said promissory note, the Mortgagor(s) did make, execute and deliver to the Mortgagee, their certain mortgage bearing date of March 3, 1978, conveying to the Mortgagee therein named the following described real property, situate in the County of Klamath, State of Oregon, to-wit:

Lot 1, Block 3 ORIGINAL PLAT OF KLAMATH RIVER ACRES, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon

which mortgage was duly recorded in the Records of Mortgages of said county and state.

There is now due and owing upon the promissory note aforesaid, the principal sum of Six Thousand Eight Hundred Seventy Six and 92/100ths* (\$ 6,876.92) DOLLARS, together with accrued interest thereon, and the Mortgagor(s) desire a modification of the terms of payment thereof, to which the Mortgagee is agreeable on the terms and conditions hereinafter stated and not otherwise.

NOW THEREFORE, in consideration of the premises and of the promises and agreements hereinafter contained, the parties hereto do hereby agree that the balance now due and owing on the promissory note hereinabove described shall be and is payable in ^{one} monthly installments of Six Thousand Eight Hundred Seventy Six and 92/100ths* (\$ 6,876.92) DOLLARS each, together with interest on the unpaid balance at the rate of 12.00 % per annum. The first ^{interest} installment shall be and is payable on the 14th day of April, 1979, and a like installment on the 14th day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest if not sooner paid, shall be due and payable on the 10th day of September, 1979. If any of said installments of either principal or interest are not so paid, the entire balance then owing shall, at the option of the Mortgagee or its successors in interest, become immediately due and payable without notice.

Except as herein modified in the manner and on the terms and conditions hereinabove stated, the said promissory note and mortgage shall be and remain in full force and effect, with all the terms and conditions of which the mortgagor(s) do agree to comply in the same manner and to the same extent as though the provisions thereof were in all respects incorporated herein and made a part of this agreement.

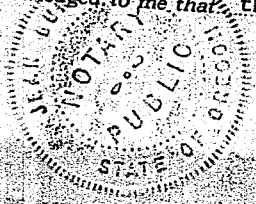
