

KNOW ALL MEN BY THESE PRESENTS, That Melvin Vanderhoff and Alphild Vanderhoff, husband and wife, hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto Oscar K. Johnson hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Beginning at a point in the Northwest quarter of southwest quarter of Section 7, Township 38 South, Range 9 East Willamette Meridian, which point is on the southerly boundary of a parcel of land conveyed by the Wilson Title and Abstract Company to Melvin Vanderhoff and Alphild Vanderhoff, the deed for which is recorded in Klamath County Deed Records, Vol. 188 at page 476, and which point of beginning is South 89° 49' East. 799 feet to the Westerly right of way boundary of the presently located Dalles California Highway, thence South 11° 36' East along said right of way boundary a distance of 1056.29 feet, and thence South 78° 24' West 100.15 feet (this distance is given as 100 feet in the above mentioned Vanderhoff deed. The actual distance between existing iron monuments is 100.15 feet), from the one quarter corner common to said Section 7 and Section 12, Township 38 South, Range 8 East, Willamette Meridian; thence North 32° 36' West, 107.1 feet, more or less, to an existing iron monument; thence North 48° 36' West, 112.7 feet, more or less, to an existing iron monument; thence North 89° 43' West 302.79 feet; thence South 69° 29' East 474.8 feet, more or less, to the point of beginning, being a portion of the Northwest quarter of southwest quarter of Section 7, Township 38 South, Range 9 East Willamette Meridian, containing 0.607 of an acre, more or less.
