heirs and assigns, forever.

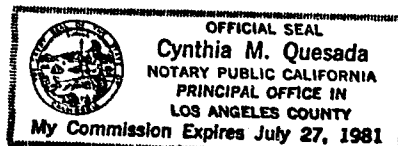
