Beginning at a point 594 feet North of an iron pin driven into the ground near the fence corner at the Southwest corner of NW% of Section 1, Township 39 South, Range 9 East of the Willamette Meridian, in the property of Otis V. Saylor, being the Southwest corner of said property abutting on the Dalles-California Highway and which iron pin is East 30 feet of the center of a road intersecting the Dalles-California Highway from the North, and which pin is North 30 feet of the center of said Highway; thence East 330 feet; thence North 66 feet; thence West 330 feet; thence South 66 feet to the place of beginning.
