proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of
a well

a tributary of South Fork Sprague River
road sprinkling

for the purpose of

under Permit No. G-1964 and that said right to the use of said waters has been perfected in
accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from
September 26, 1961

that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
0.10 cubic foot per second and shall be further limited to 60,000 gallons of
water per day

or its equivalent in case of rotation, measured at the point of diversion from the well.

The well is located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 35, T. 36 S., R. 14 E., W. M., North
86 degrees West 43.1 feet from the SE Corner, Section 35

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to ----- of one cubic foot per second
per acre,

conform to such reasonable rotation system as may be ordered by the proper state officer.
