CERTIFICATE OF WATER RIGHT

This Is to Certify, That

DONALD E. OR VIRGINIA H. SCHREINER

of Rt. 1, Box 325, Bonanza , State of Oregon, 97623 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Well No. 1

a tributary of Buck Creek irrigation of 73.7 acres

for the purpose of

under Permit No. G-5230 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 20, 1970

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.92 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE4 NE4, Section 36, T. 37 S., R. $11\frac{1}{2}$ E., W. M., 860 feet South and 150 feet West from the NE Corner, SE4 NE4, Section 36

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
