All the following described real property situate in Klamath County, Oregon:

Beginning at the Northwest corner of the SE $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 25, Township 24 South, Range 8 East of the Willamette Meridian; thence North along the West line of the NE $\frac{1}{4}$ SE $\frac{1}{4}$  to the Southeasterly line of Lot 1 in Block 7 of River West, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon; thence Northeasterly along the Southeasterly line of Lots 1 and 2 in said Block 7 to its intersection with the most Southwesterly line of Lot 3 in said Block 7; thence Southeasterly along the Southwesterly line of Lots 3 and 4 of said Block 7 to a distance of 250 feet to a point; thence South to the Northerly line of said SE $\frac{1}{4}$ SE $\frac{1}{4}$  of said Section 25; thence West to the point of beginning.

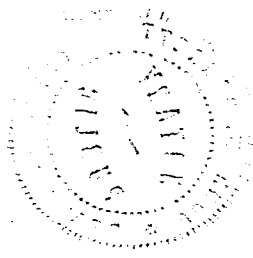

To promptly notify mortgagee in writing of a transfer of ownership of the premises or any part or interest in same, and to furnish a copy of the instrument of transfer to the mortgagee; a purchaser shall pay interest as prescribed by ORS 407.070 on all payments due from the date of transfer; in all other respects this mortgage shall remain in full force and effect.

The mortgagee may, at his option, in case of default of the mortgagor, perform same in whole or in part and all expenditures made in so doing including the employment of an attorney to secure compliance with the terms of the mortgage or the note shall draw interest at the rate provided in the note and all such expenditures shall be immediately repayable by the mortgagor without demand and shall be secured by this mortgage.

Default in any of the covenants or agreements herein contained or the expenditure of any portion of the loan for purposes other than those specified in the application, except by written permission of the mortgagee given before the expenditure is made, shall cause the entire indebtedness at the option of the mortgagee to become immediately due and payable without notice and this mortgage subject to foreclosure.

The failure of the mortgagee to exercise any options herein set forth will not constitute a waiver of any right arising from a breach of the covenants.

In case foreclosure is commenced, the mortgagor shall be liable for the cost of a title search, attorney fees, and all other costs incurred in connection with such foreclosure.

Upon the breach of any covenant of the mortgage, the mortgagee shall have the right to enter the premises, take possession, collect the rents, issues and profits and apply same, less reasonable costs of collection, upon the indebtedness and the mortgagee shall have the right to the appointment of a receiver to collect same.

The covenants and agreements herein shall extend to and be binding upon the heirs, executors, administrators, successors and assigns of the respective parties hereto.

It is distinctly understood and agreed that this note and mortgage are subject to the provisions of Article XI-A of the Oregon Constitution, ORS 407.010 to 407.210 and any subsequent amendments thereto and to all rules and regulations which have been issued or may hereafter be issued by the Director of Veterans' Affairs pursuant to the provisions of ORS 407.020.
