CERTIFICATE OF WATER RIGHT

This Is to Certify, That J. F. ARROYO

of 1085 Telegraph St., Reno, State of Nevada, 89520, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Well No. 1

a tributary of North Fork Sprague River for the purpose of irrigation of 45.0 acres

under Permit No. G-1999 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 28, 1961 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.56 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 7, T. 36 S., R. 14 E., W. M., 2075 feet South and 100 feet West from the NE Corner, Section 7

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

24.6 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$
5.7 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$
0.5 acre SW $\frac{1}{4}$ NE $\frac{1}{4}$
14.2 acres SE $\frac{1}{4}$ NE $\frac{1}{4}$
Section 7
T. 36 S., R. 14 E., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
