KNOW ALL MEN BY THESE PRESENTS, That PEYTON & COLOR, an Oregon corporation, Grantor, for the consideration of the sum of Two Thousand and No/100 DOLLARS (\$2,000.00) received, does hereby convey unto the STATE OF OREGON, by and through its DEPARTMENT OF TRANSPORTATION, Highway Division, Grantee, the following described property, to wit:

A parcel of land lying in Lot 2 of Section 18, Township 38 South, Range 9 East, W.M., Klamath County, Oregon and being a portion of that property described in that deed to Peyton & Co., recorded in Book M-77, Page 5368 of Klamath County Record of Deeds; the said parcel being that portion of said property lying Northwesterly of a line at right angles to the center line of the relocated The Dalles-California Highway at Engineer's Station 82+00 and included in a strip of land variable in width, lying on the Northeasterly side of said center line, which center line is described as follows:

Beginning at Engineer's center line Station 80+00, said station being 1501.8 feet South and 66.6 feet East of the Northeast corner of said Lot 2; thence North 52° 38' West 654.8 feet; thence on a 1909.9 foot radius curve right (the long chord of which bears North 30° 01' West) 1507.8 feet to Engineer's center line Station 101+62.6.
