## RIGHT FOR ROAD USE

For value received the undersigned, hereinafter referred to as "Grantors", hereby grant to PACIFIC POWER & LIGHT COMPANY, a corporation, its successors and assigns, Grantee, the right to use, improve, maintain and repair an existing road as necessary for the construction, operation and maintenance of an electric power line, said road being over, across and upon Grantor's real property situated in the NE  $\frac{1}{4}$  of Section 32, Township 40 South, Range 12 East, W.M., Klamath County, State of Oregon. Said road is located on said real property approximately as shown on the plat marked EXHIBIT "A" attached hereto and made a part hereof.

Grantor shall have the right to install or retain roadway locking facilities across the roadway; however, in cases where a lock is installed, Grantee may also install its own lock.

During the period in which the road is being used to facilitate the construction of the power line, Grantee shall maintain the road.

All said rights herein granted shall cease if the power line is abandoned.

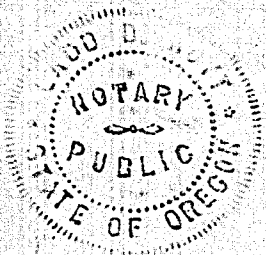
