NURSERYMAN'S LIEN

KNOW ALL MEN BY THESE PRESENTS: The undersigned, hereinafter called the Claimant, dba ALTAMONT NURSERY CO., a filed assumed business name, did on or about March 15, 1979, enter into an oral contract with MARTIN E. ADAMS and ELIZABETH BETTY ADAMS, husband and wife, to landscape the front yard of Lot 11, Block 2, East Hills Estates Second Addition, Klamath County, Oregon, also known as 2121 Kimberly Drive, Klamath Falls, Oregon, for an agreed price of \$2,690.00 for the furnishing of shrubbery and landscaping materials and the labor required to landscape said real property.

That said landscaping job was completed on April 10, 1979, within the 120 days allowed plaintiff for the filing of its notice of lien pursuant to ORS 87.366.

That on or about April 29, 1979, plaintiff gave defendants a \$390.00 credit on said job reducing the cost for said job to the sum of \$2,300.00, and on April 30, 1979, the defendants paid \$1,500.00 of said debt leaving a balance then due and owing of \$800.00. That the defendants are the owners, or at least the reputed owners, of said land described above and had knowledge at all times that said landscaping was being done to the real property described.

That plaintiff has made demand upon defendants for payment of said \$800.00, and defendants have failed and refused to pay same and continue to fail and refuse to pay same. That there is now due and owing from defendants to plaintiff after credit for all offsets and payments the sum of \$800.00.

That plaintiff claims a lien for said \$800.00 against the above described real property together with land that may be required for the convenient occupation and use of the site to be determined by the Court at the time of the foreclosure of this lien.

In construing this instrument, the masculine pronoun means and includes the feminine and the neuter, and the singular includes the plural, as the circumstances may require.
