THIS AGREEMENT, made and entered into this <u>30th</u> day of <u>July</u>, 19 79, by and between <u>HENRY L. NEWLAND and ANNE C. NEWLAND</u>, husband and wife

hereinafter called the "Mortgagor", and WESTERN BANK, Coos Bay, Oregon, an Oregon banking corporation, hereinafter called the "Mortgagee":

WITNESSETH: On or about the <u>31st</u> day of <u>May</u>, 19<u>78</u>, the Mortgagor(s) did make, execute and deliver to the Mortgagee their certain promissory note in the sum of \$15,325,12, payable in monthly installments with interest at the rate of <u>11.00</u>% per annum. ## which mortgage was duly recorded in the Records of Mortgages of said county and state.

There is now due and owing upon the promissory note aforesaid, the principal sum of <u>Thirteen Thousand</u> <u>One Hundred Forty Two and 18/100\* \* \* \* (§ 13,142.18</u>) DOLLARS, together with accrued interest thereon, and the Mortgagor(s) desire a modification of the terms of payment thereof, to which the Mortgagee is agreeable on the terms and conditions hereinafter stated and not otherwise.

NOW THEREFORE, in consideration of the premises and of the promises and agreements hereinafter contained, the parties hereto do hereby agree that the balance now due and owing on the promissory note hereinabove described shall be and is payable in monthly installments of <u>One Hundred Fifty Five and no/100\* \* \*</u> \* \* \* \* \* \* (\$ 155.00 \_\_\_\_\_\_) DOLLARS each, <u>including</u> interest on the unpaid balance at the rate of <u>13.50</u> % per annum. The first installment shall be and is payable on the <u>30th</u> day of <u>August</u>, <u>19.79</u>, and a like installment on the <u>30th</u> day of each not sooner paid, shall be due and payable on the <u>30th</u> day of <u>October</u>, <u>19.79</u>. If any of said installments of either principal or interest are not so paid, the entire balance then owing shall, at the option of the Mortgagee or its successors in interest, become immediately due and payable without notice.

Except as herein modified in the manner and on the terms and conditions hereinabove stated, the said promissory note and mortgage shall be and remain in full force and effect, with all the terms and conditions of which the mortgagor(s) do agree to comply in the same manner and to the same extent as though the provisions thereof were in all respects incorporated herein and made a part of this agreement.
