

KNOW ALL MEN BY THESE PRESENTS, that the City of Klamath Falls, a municipal corporation, hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto Edward Putman, Grantee, for the term of Edward Putman's life, then go to Jeanne Calvin, hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the City of Klamath Falls, County of Klamath, State of Oregon, described as follows, to wit:

A parcel of land situated in Lot 20 of Lakeshore Gardens and in Lot 7, Block 8 of Lynnewood First Addition, both being subdivisions, in Klamath County, Oregon, being more particularly described as follows:

Beginning at the Southeast Corner of said Lot 20; thence, N04°51'34"E along the East Line of said Lot 20, 221.41 feet; thence, S22°57'04"W, 144.92 feet; thence, S04°51'34"W, 99.00 feet to a point on the South Line of said Lot 7; thence Easterly on said South Line along A 363.88 foot radius curve to the right, 45.05 feet; thence N04°51'34"E, 14.09 feet to the point of beginning,

according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, free of all encumbrances except reservations, restrictions, easements and rights-of-way of record and those apparent upon the land.

To have and hold the same unto the said grantee and grantee's heirs, successors and assigns forever.

The true and actual consideration paid for this transfer, stated in terms of dollars, is Three thousand five hundred thirty-three and 64/100 Dollars (\$3,533.64).

In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.

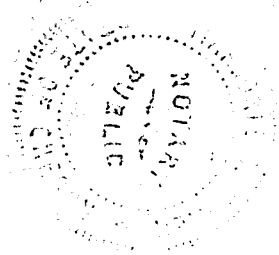
