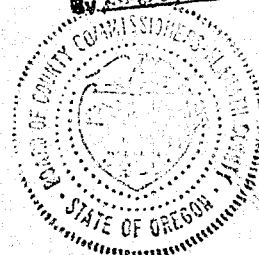
1. Taxes for the fiscal year 1979-1980, a lien, not yet due and payable.
