KNOW ALL MEN BY THESE PRESENTS, That Terry Blackburn and Linda Blackburn

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by Furman Tupper

the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

The following described real property in BAILEY TRACTS, more particularly described as follows:
