THIS AMENDMENT TO LEASE made this 10 day of August, 1979, by and between R. THEODORE LINDLEY and PATRICIA E. LINDLEY, hereinafter called Lessors and JOHN E. ZELNAR, hereinafter called Lessee.

In all other particulars said lease is affirmed and shall remain in full force and effect according to the terms thereof.
