WHEREAS, on the 6th day of April, 1979, a Petition for Vacation duly executed by Richard Jessup was filed with the Board of Commissioners of Klamath County, Oregon; and

WHEREAS, the Board of County Commissioners set a public hearing on the said Vacation for the hour of 10:00 A.M. on the 9th day of May, 1979, in the Commissioners' Hearing Room in the Annex to the Klamath County Courthouse, Klamath Falls, Oregon; and

WHEREAS, the above-mentioned hearing was duly held and further continued hearings were duly held on the 7th day of June, 1979; the 24th day of July, 1979; and the 15th day of August, 1979; and

WHEREAS, it was determined at said hearings that said CHEMULT is a platted and subdivided tract of acreage in Klamath County, Oregon, outside the limits of any incorporated City or Town and that all of the Alleys located in said Chemult which are included in said Petition for Vacation are Public Roads other than County Roads or State Highways and have never been opened or used by the public or by any person; that litter and garbage in said Alleys are a danger to Public health and safety; that the Public will benefit from improvement of the area by adjoining landowner-petitioner; that certain private utilities are presently using a part of the Alleys in block 1 for the transmission of electric power and telephone services and that said utilities' use of said Alleys will be protected by an existing easement and an additional easement to be granted by petitioner to said utilities; that proper Notice of the Petition to Vacate and the Hearing thereon was properly posted in three of the most public and conspicuous placed within the limits of the platted acreage to be vacated and that said Notice was duly posted more than four weeks prior to the time set for Hearing; and

WHEREAS, it was determined at said Hearings that no opposition has been made to said Petition; that one landowner, R. A. Briggs & Sons, who would be particularly affected by Vacation of all of the Alleys in said Block I has not consented to said Vacation; that the County Engineer determined and reported that Vacation of all the Alleys in said Block I would adversely affect said R. A. Briggs & Sons by eliminating all access to a portion of said owner's property in said Block I; and

WHEREAS, it was determined that a portion of the Alleys in said Block 1 could be Vacated without affecting said R. A. Briggs and Sons; that the owners of land adjoining said portion of the Alleys in said Block 1 are Richard Jessup, Virginia Jessup and Ethel Jessup; that two private utilities, Mid-State Electric Cooperative and Telephone Utilities of Eastern Oregon, would be particularly affected by the Vacation of said portion of the Alleys; that said adjoining landowners and said utilities have consented to said Vacation in writing, which said Consent has been acknowledged before a Notary Public and filed with the Board of Commissioners of Klamath County, Oregon; that the Public will benefit from the Vacation of said portion of said Alleys in the same ways as the Public would benefit from Vacation of all the Alleys in said Block 1; that the description of said portion of said Alleys as set forth in the attached Exhibit A is a true and correct description of said portion of said Alleys; that all of the statements set forth in said Petition to Vacate are true; and the Board of County Commissioners now being fully advised in the premises,

IT IS HEREBY ORDERED, pursuant to the provisions of ORS 271.010 to 271.070, that all of the tract in said CHEMULT, Klamath County, Oregon, described in Exhibit A, attached hereto and by this reference made a part hereof, be and the same is hereby Vacated.
