A portion of Lot 8, Block 5, First Addition to Keno Whispering Pines, more particularly described as follows: Beginning at a 1/2" rebar on the Northerly right of way line of Pioneer Drive, from which a 5/8" rebar marking the Southwest corner of Lot 8, Block 5 bears West 215.31 feet; thence N. 00° 04' 48" E. 315.00 feet to a 1/2" rebar; thence East 215.09 feet to a 1/2" rebar; thence S. 00° 02' 24" W. 315.00 feet to a 1/2" rebar on the Northerly right of way line of Pioneer Drive; thence West 215.31 feet, along said right of way line, to the point of beginning.


