KNOW ALL MEN BY THESE PRESENTS, That ROBERT D. PUCKETT

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by KENO RURAL FIRE PROTECTION DISTRICT, hereinafter called

the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath, and State of Oregon, described as follows, to-wit:

A parcel of land 133 feet in width lying generally South of the lands deeded by the grantor herein to the grantee herein on the 23rd day of December, 1978, recorded Volume M-78, Page 28791, Deed Records of Klamath County, Oregon, containing .6 of an acre and situate in Sec. 31, Township 39 South, Range 8 E., W.M., described as follows: Beginning at a point on the Southeasterly right of way of the old County Road, known as "Puckett Road" from which the most Easterly corner of Lot 1, Block 1, Klamath River Acres bears the following two bearings and distances: N 46°02'47" E 173.37 feet, N 46°35'18" W 291.18 feet; thence from said point of beginning S 48°27'49" E 194.13 feet; thence S 46°02'47" W 353.37 feet, N 50°20'00" W 195.75 feet to the Southeasterly right of way of said "Puckett Road", thence N 46°02'47" E along the Southeasterly right of way of said "Puckett Road" 359.78 feet to the point of beginning, containing 1.6 acres, more or less.

Subject to easements and rights of way of record and those apparent on the land.
