## Know all Men by these Presents:

That Robert D. Lyells

lands, and all deeds and other assurances in the law therefor, and to lease, let, sell

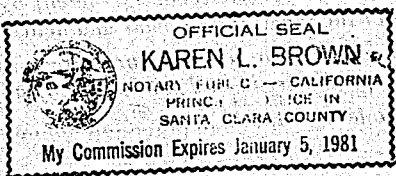
