 - If the space provided for any item(s) on the form is inadequate, the item(s) should be continued on additional sheets, preferably 8 1/2" x 11". Only one copy of such additional sheets need be presented to the filing officer. Long schedules of collateral, indentures, etc. may be on any size paper that is convenient for the secured party.
 - DO NOT STAPLE OR TAPE ANYTHING TO LOWER PORTION OF THIS FORM.**
 - The filing officer who receives county filing officers who record real estate mortgages.
 - At the time of original filing, filing officer will return acknowledgment copy to the assignee if noted on form or secured party.
 - When a copy of the security agreement is used as a financing statement, it is requested that it be accompanied by a completed UCC-21 form.
 - When a copy of the security agreement is used as a financing statement, it is requested that it be accompanied by the secured party or assignee or he may use Form UCC-3 or UCC-3A as a Termination Statement.

7. When a copy of the security agreement is filed with the Uniform Commercial Code, this document shall be deemed to be a copy of the security agreement.
8. When filing is to be terminated, the acknowledgment shall be filed with the Uniform Commercial Code as a Termination Statement.
