of Klamath , State of Oregon, described as follows, to-wit:
All that portion of Lot 7 of Section 6 in Township 39 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon, starting at the Southwest corner of said Lot, running East 794 feet and thence North to a point on the North boundary line of the Right of Way of the Enterprise Irrigation Canal which is the true point of beginning; thence running Northwesterly along the said North line of said Canal Right of Way to a point which is 400 feet East of the West Boundary of said Lot 7; thence North to the North boundary of said Lot 7; thence East along the said North boundary of said Lot 7 (394 feet more or less) to a point North of the true point of beginning; thence South to said point of beginning.
