THIS AGREEMENT, made and entered into by and between WILLIAM R. DODGE and NANCY E. DODGE, husband and wife, and LARRY L. TODD and ASTRID E. TODD, husband and wife, hereinafter called Grantors and WILLIAM E. ZLOMKE and DARLENE ZLOMKE, husband and wife, hereinafter called Grantees,

WITNESSETH:

WHEREAS, WILLIAM E. ZLOMKE and DARLENE ZLOMKE, husband and wife, are the successors in interest to RICHARD P. SUMNER and MARCIA R. SUMNER, husband and wife, the First Party in that certain Hot Well Water Agreement, dated the 21st day of March, 1978 and recorded on April 14, 1978 in Volume M78, page 7284, Klamath County Deed Records, by and between RICHARD P. SUMNER and MARCIA R. SUMNER, husband and wife, therein called First Party; WILLIAM R. DODGE and NANCY E. DODGE, husband and wife, therein called Second Parties; and STEVEN B. PRESLAR and JUDY PRESLAR, husband and wife, therein called Third Parties, which said Agreement did not provide Grantees with an easement for ingress and egress for purposes of maintaining the pipe, well and heating system from the location of the said well, which is located on the Northwesterly corner of the alley vacated by the City of Klamath Falls, Oregon, by ordinance No. 5376, located on a portion of Lot 15, Block 40, HILLSIDE ADDITION TO THE CITY OF KLAMATH FALLS, in the County of Klamath, State of Oregon, across a strip of land one foot wide, the center line of said strip beginning at the said well and extending in a Northeasterly direction over and across the real property owned by LARRY L. TODD and ASTRID E. TODD, husband and wife, described as follows:

NOW, THEREFORE, we the undersigned being the owners of the foregoing described parcels of property hereby grant to the Grantees, their heirs, successors and assigns a perpetual easement to lay and construct pipes for the purpose of conducting hot water to the above described real property owned by Grantees together with the right of ingress and egress for the purpose of maintaining the pipe, well, and heating system over and across the property owned by the undersigned Grantors.

This easement shall be appurtenant to the property of Grantees and shall be for the use and benefit of Grantees property.
