AMENDMENT OF CONTRACT

This agreement modifies an existing land sale contract dated June 23, 1977, recorded June 23, 1977 in Vol. M77, Page 11080, between CARL COSTELLOE and IRENE COSTELLOE, as seller, and KAREN SARTIN, as buyer, the seller's interest subsequently assigned to Pacific West Mortgage Co. by deed and assignment, such deed being dated September 14, 1979, recorded October 1, 1979 in Vol. M79, page 23164, in Klamath County Deed Records and assignment being dated September 14, 1979, recorded on October 1, 1979 in Book M79, page 23163, Klamath County Deed Records, regarding the following described property:

The following described real property is situated in the SW $\frac{1}{4}$, SW $\frac{1}{4}$ of Section 22, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, being more particularly described as follows:

Beginning at the NW corner of the SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 22, Township 39 South, Range 9 East of the Willamette Meridian; thence South 88° 56' East, along the North line of the SW $\frac{1}{4}$ SW $\frac{1}{4}$ to the Westerly right-of-way line of the U.S.B.R. Weed drain; thence Southerly and Westerly along the Westerly and Northerly right-of-way line of the Weed drain to its intersection with the West line of the SW $\frac{1}{4}$ SW $\frac{1}{4}$; thence North 0° 04' East, along the West line of the SW $\frac{1}{4}$ SW $\frac{1}{4}$ to the point of beginning.

EXCEPTING THEREFROM any portion lying within the right-of-way of Washburn Way.

Hereafter, the payment on said contract shall be \$120.00 per month including six (6) per cent per annum interest, payable on the 1st day of each and every month until the entire balance and accrued interest has been paid in full.
