DECREE OF
DISSOLUTION OF MARRIAGE

THIS CAUSE Came on regularly for trial this day, before the court, sitting without a jury, at Idaho Falls, Idaho, plaintiff appearing in person and by her counsel, DENMAN, REEVES & OHMAN, by REGINALD R. REEVES, ESQ., and defendant not appearing, either in person or by counsel. It appearing from the testimony that plaintiff is entitled to the relief requested, and the making of findings of fact and conclusions of law having been waived, with the approval of the court:

IT IS HEREBY ORDERED That the bonds of matrimony heretofore existing between plaintiff and defendant are hereby dissolved; and plaintiff is hereby granted a decree of dissolution of marriage from defendant.

AND IT IS ORDERED As follows:

1. Defendant is hereby required to pay all medical, dental, and optical expenses incurred by plaintiff (in excess of her insurance coverage), through the year 1982.

2. The community property is hereby divided by awarding to plaintiff, the property described as:

1974 Nashua mobile home
Miscellaneous furniture, furnishings
and appliances located therein
1975 Oldsmobile coupe

Policies of insurance with
Northern Life Insurance
Company and Mutual of Omaha
Balance due from Granite Chief
Corporation, pursuant to
Escrow #83-A1-359, with
U. S. National Bank,
Chiloquin, Oregon
One-half of the balance due from
RICHARD J. SMITH and BARBARA A.
SMITH, pursuant to a contract
dated August 22, 1966 and
Her clothing, jewelry, sporting
equipment and personal effects

by awarding to defendant, the property described as:

1972 Teton mobile home
1975 Dodge pickup truck
Metal shed and tools (valued
at \$450)
Native American artifacts
One-half of the balance due
from RICHARD J. SMITH and
BARBARA A. SMITH, pursuant
to a contract dated August
22, 1966
Cash in the sum of \$2,000, to be
paid to defendant by plaintiff and
His clothing, jewelry, sporting
equipment and personal effects

and by awarding to plaintiff and defendant, as tenants in common, the remaining
real property of the parties in the State of Oregon, provided that (1) the
proceeds of such Smith contract shall be used to pay the encumbrances against
such real property, until the sale of such real property, and (2) upon such
sale, each party shall receive 50% of the net proceeds thereof.

3. If the BIA allotment (in the approximate amount of \$7,500)
received by defendant should be determined to be "income," and thus, community
property, pursuant to the law of the State of Idaho, defendant shall pay to
plaintiff an amount equal to 50% thereof. And

4. Defendant is hereby required to pay to plaintiff, for her
attorneys' fees and costs incurred herein, the sum of \$685.
