THIS INDENTURE, made this 15th day of May, 1979, between the UNITED STATES OF AMERICA, acting therein by and through the Director of Lands, Forest Service, Department of Agriculture, hereunto duly authorized by the Act of March 1, 1911, as amended (16 U.S.C. 516), and the Federal Land Policy and Management Act of 1976 (43 U.S.C. 1716), the delegation of authority by the Secretary of Agriculture to the Assistant Secretary for Conservation, Research and Education (7 CFR 2.19), and the delegation of authority from the Assistant Secretary for Conservation, Research and Education to the Chief, Forest Service (7 CFR 2.60), and the delegation of authority by the Chief, Forest Service (43 Fed Reg. 1633), the provisions of which have been complied with, Grantor, and the State of Oregon, acting by and through its Board of Forestry, Grantee:

WITNESSETH: That the Grantor, for and in consideration of the conveyance to it by the Grantee of land in Klamath County, Oregon, more particularly described in the deed to the United States executed January 19, 1979, recorded January 24, 1979, as Auditor's File No. 61650, Volume M 79, Page 2115, Official Records of Klamath County, Oregon, which is of equal value to the land herein conveyed, the receipt of which is hereby acknowledged, does hereby remise, release and quitclaim to the Grantee all interest in the following described real estate situate in the County of Klamath, State of Oregon:

That portion of Township 33 S., Range 7 E., W.M., as follows:

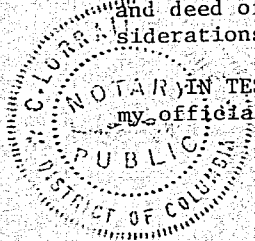
