KNOW ALL MEN BY THESE PRESENTS, That the undersigned, for the consideration hereinafter stated, has sold and assigned and hereby does grant, bargain, sell, assign and set over unto STEVEN D. SHOCKEY and IRENE SHOCKEY

his heirs, successors and assigns, all of the vendee's right, title and interest in and to that certain contract for the sale of real estate dated July 22, 1976, between FORREST A. FREID AND JUANITA R. FREID as seller and TOMMY HAMRICK AND JOYCE HAMRICK
