I, SAYDE M. BAKER, being first duly sworn, depose and say:

That I am one of six children of Napoleon B. Wade and Anna Wade. My mother and father divorced in approximately 1925. Some years later, my father purchased certain real property located in Klamath County, Oregon, described as follows:

Beginning at a point 30.25 feet North 14°27' West of the Northwest corner of Lot 1, Block 2, FIRST ADDITION TO BUENA VISTA ADDITION; thence North 68°11' East 61.3 feet; thence North 115.87 feet to the South line of Bismark Street; thence North 76°30' West 101.35 feet along the South side of Bismark Street to the East line of Frederick Street, now known as Front Street; thence South 14°27' East along the East side of Frederick Street, now known as Front Street, to the point of beginning.

My father did not remarry. He died on October 13, 1958 in Klamath Falls, Oregon. He died without a will having been made. The above-described real property remained in his name upon his death.

Leona W. Lee died on October 12, 1973 in Lake Oswego, Oregon. She was divorced at the time of her death, and left no will. She had had one daughter, one Donna Lee Tandy. Donna Lee Tandy died on November 3, 1970 and was divorced at the time. Donna Lee Tandy did not have a will, but did have four children whose names are Joan Miller, Sandy Reinhart, Jeannette Hammitt and Robin Tandy.

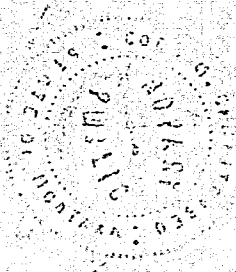
