## WITNESSETH:

WHEREAS, Grantors are the owners of a tract of land situated in SW%NW%, Section 18, Township 39 South, Range 10 E., W.M., which tract of land has heretofore been sold by the Grantors to Harry R. Waggoner and Norma E. Waggoner, husband and wife; and

WHEREAS, Thomas A. Ayres is the owner of two tracts of land situated in the SW4NW4, Section 18, Township 39 South, Range 10 E., W.M., more particularly described in Deeds recorded with the County Clerk of Klamath County, Oregon, in Deed Records Volume M-79, Page 10005, and Volume M-79, Page 7265; and

WHEREAS, Waggoners as Contract Purchasers have agreed to sell and convey a one-third interest in an existing well on the said property being purchased from Grantors herein, together with an easement for water line and the maintenance thereof; and the parties being fully advised, Now, Therefore,

FOR AND IN CONSIDERATION Of the sum of § mone, receipt whereof is hereby acknowledged by Waggoners, the Grantors do by these presents grant, set over and convey unto THOMAS A. AYRES, his heirs, personal representatives and assigns, a one-third interest in the well situate on the property being purchased by Waggoners together with an easement for water line, more particularly described as follows:

Legal description of a 10 foot water line easement situated in the  $SW_4NW_4$ , Section 18, T.39 S., R. 10 E.,W.M., Klamath County, Oregon, the southerly line of said easement being more particularly described as follows: Beginning at the southeasterly corner of that tract of land described in Deed Volume M79 - 10005, as recorded in the Klamath County Deed Records, said corner being S 23°37'26" E 2114.18 feet from the northwest corner of said Section 1S; thence S 43°08'30" E 185.00 feet; thence along the arc of a curve to the left (central angle =  $47^{\circ}04'46''$ , radius = 100.00 feet) 82.17 feet; thence southeasterly 26 feet, more or less, to a point 5.00 feet southwesterly of an existing well, with bearings based on said deed volume M79-10005.

Grantee shall have the right to maintain a buried pipe line (buried a minimum of twenty-four inches), on the hereinabove described premises; the right to install a pump of his own choosing in said well, at his own cost and expenses; PROVIDED,

However, if additional users are added, the Grantee shall be entitled to recover prorata cost of the installation together with the cost of operation for said pump.

This Agreement shall be perpetual or until such time as the domestic water supply is furnished from another source acceptable to the Department of Veterans' Affairs of the State of Oregon.

TO HAVE AND TO HOLD The above-described grant and easement unto the Grantee, his heirs, personal representatives and assigns forever.
