A G R E E M E N T

THIS AGREEMENT, entered into on the 29th day of March, 197⁸, by and between SHASTA VIEW IRRIGATION DISTRICT, an irrigation district in the State of Oregon, hereinafter referred to as District, and EDWIN J. STASTNY, JR., and DIANA F. STASTNY, husband and wife, of Malin, Oregon, hereinafter referred to as Grantors,

RECITALS:

1. On the 23rd day of July, 1973, the District entered into a contract and grant of easement with Dale Childers, Frances Kent Peterson and Robert Kent concerning real property located in the State of Oregon, which agreement was recorded in Volume ^{ed} M-73, Page 1083 of the Official Records of Klamath County, Oregon, and being a portion of the NE 1/4 of Section 32, Township 40 S., Range 12 East of the Willamette Meridian in Klamath County, Oregon.
2. Subsequent to that time the Grantors have purchased said parcel of real property and are now the owners thereof.
3. In the interest of good farming practices it has become desirable for the parties to cause the access road portion of the easement prior conveyed to the District to be shifted in some small respects, therefore, in consideration of the mutual covenants contained within this document, it is agreed between the parties as follows:
 1. That the following provision "together with the right to construct an access road for ingress and egress over the East 15.00 feet of the above described easement" be and the same is hereby modified to read as follows: "together with the right to construct and use an access road for ingress and egress over the West 22.00 feet of the above described easement."
 2. Except as modified herein the original agreement dated the 23rd day of July, 1973 heretofore described, shall remain in full force and effect.

IN WITNESS WHEREOF the parties have caused this amended contract and grant of easement to be executed the day first hereabove written.

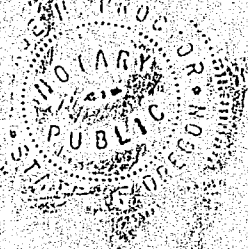
