hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by ALMON J. KING, RUTH E. KING, KEITH L. KING, MARION J. YAPLE, MARJORIE A. REDKEY, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Beginning at a point 720 feet East and 1237.5 feet North of an iron pin driven into the ground on property of Otis V. Saylor, at the Southwest corner of the NW $\frac{1}{4}$ of Section 11, Township 39 South, Range 9 East of the Willamette Meridian, which iron pin is 30 feet East of the center of a road intersecting the Klamath Falls-Lakeview Highway from the North, and 30 feet North of the center of said Highway; thence East a distance of 198 feet, more or less, to a $\frac{1}{2}$ " iron pipe approx 30" long driven in the ground, which is the TRUE POINT OF BEGINNING of this legal description; thence North 132 feet to an iron pin; thence East 80 feet to an iron pin; thence South 132 feet to an iron pin; thence West 80 feet to the true point of beginning
