as security for an additional advance in the amount of \$ 65,600.00, together with the balance of indebtedness covered by the previous note, and the new note is evidence of the entire indebtedness.

- Not to permit the buildings to become vacant or unoccupied; not to permit the removal or demolishment of any buildings or im-provements now or hereafter existing; to keep same in good repair; to complete all construction within a reasonable time in accordance with any agreement made between the parties hereto. Not to permit the cutting or removal of any timber except for his cwn domestic use; not to commit or suffer any waste;
- 4. Not to permit the use of the premises for any objectionable or unlawful purpose;
- Not to period any tax, assessment, lien, or encumbrance to exist at any time;
- Monitories is authorized to pay all real property taxes assessed against the premises and add same to the principal, each of the anti-most to bear interest as provided in the note;
- To very all buildings unceasingly insured turing the term of the mortgage, against loss by fire and such other hazards in such on any or companies and in such an amount as shall be satisfactory to the mortgagee: to deposit with the mortgagee all such soluties with receipts showing payment in full of all premiuris; all such insurance shall be made payable to the mortgagee: an u ance shall be kept in force by the mortgagor in case of foreclosure until the period of redemption expires;

The mortgagee may, at his option, in case of default of the mortgagor, perform same in whole or in part and all expenditures made in so doing including the employment of an attorney to secure compliance with the terms of the mortgage or the note shall draw interest at the rate provided in the note and all such expenditures shall be immediately repayable by the mortgagor without demand and shall be secured by this mortgage.

Default in any of the covenants or agreements herein contained or the expenditure of any portion of the loan for purposes other than those specified in the application, except by written permission of the mortgagee given before the expenditure is made. shall cause the entire indebtedness at the option of the mortgagee to become immediately due and payable without notice and this mortgage subject to foreclosure.

The failure of the mortgagee to exercise any options herein set forth will not constitute a waiver of any right arising from a breach of the covenants.

In case foreclosure is commenced, the mortgagor shall be liable for the cost of a title search, attorney fees, and all other costs incurred in connection with such foreclosure.

Upon the breach of any covenant of the mortgage, the mortgage shall have the right to enter the premises, take possession, collect the rents, issues and profits and apply same, less reasonable costs of collection, upon the indebtedness and the mortgagee shall have the right to the appointment of a receiver to collect same.
