South 1/2 of Government Lot 4 in Section 4, Township 37 South, Range 12 East, W.M.

This conveyance is made subject to easements, rights of way of record and those apparent on the land and Grantor reserves an easement for joint user roadway and all other roadway purposes over and across a 30 ft. wide strip of land laying east of adjoining and parallel to the westerly boundard.
