WAIVER INSTRUMENT

WHEREAS, by Quitclaim Deed dated June 3, 1957, duly recorded, the United States of America, acting by and through the Secretary of Health, Education, and Welfare, acting by and through the Regional Director for Region IX of the Department of Health, Education, and Welfare, pursuant to the authority contained in the Federal Property and Administrative Services Act of 1949 (63 Stat. 377), as amended, conveyed to the County of Klamath in the State of Oregon a tract of land of approximately 86.41 acres, particularly described in said Quitclaim Deed; and

WHEREAS, said conveyance was made expressly subject to the right of the United States of America to the full and unrestricted possession, control, and use of the said tract of land during any period of national emergency; and

WHEREAS, the County of Klamath in the State of Oregon has now sought waiver of the aforementioned right of the United States to use of the tract of land during national emergency; and

WHEREAS, the United States Department of Defense has exercised the necessary authority permitting the waiver of the aforementioned right of the United States to use of the tract of land during national emergency, and the United States of America now wishes to waive this right to use of the tract of land during national emergency;

NOW THEREFORE, the United States of America acting by and through the Secretary of Health, Education, and Welfare, acting by and through the Chief, Real Property Management, Department of Health, Education, and Welfare, Region X, hereby waives the following condition set forth in the aforementioned Quitclaim Deed of June 3, 1957:

The said GRANTEE by the acceptance of this deed, further covenants and agrees, for itself, its successors and assigns, that the UNITED STATES OF AMERICA shall have the right during any period of emergency declared by the President of the United States or by the Congress of the United States to the full unrestricted possession, control and use of the property hereby conveyed, or of any portion thereof, including any additions or improvements thereto made subsequent to this conveyance. Prior to the expiration or termination of the period of restricted use by the GRANTEE, such use may be either exclusive or nonexclusive and shall not impose any obligation upon the Government to pay rent or any other fees or charges during the period of emergency, except that the Government shall (i) bear the entire cost of maintenance of such portion of the property used by it exclusively or over which it may have exclusive possession or control, (ii) pay the fair share, commensurate with the use, of the cost of maintenance of such of the property as it may use nonexclusively or over which it may have nonexclusive possession or control, (iii) pay a fair rental for the use of improvements or additions to the premises made by the said GRANTEE without Government aid, and (iv) be responsible for any damage to the property caused by its use, reasonable wear and tear, and acts of God and the common enemy excepted.
