MORTGAGOR FURTHER COVENANTS AND AGREES:

- 6. Mortgagee is authorized to pay all real property taxes assessed against the premises and add same to the principal, each of the advances to bear interest as provided in the note;

To keep all buildings unreasingly insured during the term of the mortgage, against loss by fire and such other hazards in such company or companies and in such an amount as shall be satisfactory to the mortgage; to deposit with the mortgagee all such policies with receipts showing payment in full of all premiums; all such insurance shall be made payable to the mortgagee; maurance shall be kept 13 force by the mortgager in case of foreclosure until the period of redemption expires;
