GIENGER ENTERPRISES INC., an Oregon corporation, hereinafter referred to as "Gienger," is the owner of the NE¼ of Section 26, Township 34 South, Range 8 East, W.M., Klamath County, Oregon, and; WEYERHAEUSER COMPANY, a Washington corporation, hereinafter referred to as "Weyerhaeuser," is the owner of the NW¼ of Section 25, the SE¼ of Section 26, and the E½NE¼ of Section 34, all in Township 34 South, Range 8 East, W.M., Klamath County, Oregon, and;

' CLIFTON J. PERRIN and JEANETTE F. PERRIN, husband and wife, hereinafter referred to as "Perrin," subject to a Contract of Sale to ELLIE BLEVINS and DOLORES BLEVINS, husband and wife, hereinafter referred to as "Blevins," are the owners of the NW%NE% of Section 35, Township 34 South, Range 8 East, W.M., Klamath County, Oregon, and;

ROBERT MOISIO and DOROTHEA M. POOLE, hereinafter referred to as "Moisio and Poole," are the owners as to an undivided 1/2 interest each, of the N½NW¼ and the SE¼NW¼ of Section 35, Township 34 South, Range 8 East, W.M Klamath County, Oregon, and;

NOW, THEREFORE: In consideration of the foregoing and of the grants and agreements hereinafter made:

Weyerhaeuser hereby grants and conveys to Moisio, Gienger, Blevins, and Moisio and Poole, their heirs, successors, and assigns, a perpetual non-exclusive easement upon, over and along a right of way sixty (60) feet in width over and across that portion of the ENNEX, lying North of Sprague River Road, of Section 34, Township 34 South, Range 8 East, W.M., Klamath County, Oregon, located approximately as shown in red on the attached Exhibit A.

Subject as to said lands to all matters of public record. B. Weyerhaeuser hereby grants and conveys to Moisio and Gienger, their heirs, successors, and assigns, a perpetual nonexclusive easement upon, over and along a right of way over and across the west thirty (30) feet of the NW¼ of Section 25, Township 34 South, Range 8 East, W.M., Klamath County, Oregon, located approximately as shown in yellow on the attached Exhibit A., and a perpetual non-exclusive easement upon, over and along a right of way sixty (60) feet in width over and across that portion of the NE½SE½;S½SE¼ of Section 26, Township 34 South, Range 8 East, W.M., Klamath County, Oregon, located approximately as shown in lavender on the attached Exhibit A.

Subject as to said lands to all matters of public record. C. Moisio and Poole hereby grant and convey to Moisio, Gienger, Weyerhaeuser, and Blevins, their heirs, successors and assigns, a perpetual non-exclusive easement upon, over and along a right of way sixty (60) feet in width over and across that portion of the N½NW¼ of Section 35, Township 34 South, Range 8 East, W.M., Klamath County, Oregon, located approximately as shown in green on the attached Exhibit A.

Subject as to said lands to all matters of public record.

D. Blevins hereby grants and conveys to Moisio, Gienger, and Weyerhaeuser, their heirs, successors and assigns, a perpetual non-exclusive easement upon, over and along a right of way sixty (60) feet in width over and across that portion of the NW\4NE\4 of Section 35, Township 34 South, Range 8 East, W.M., Klamath County, Oregon, located approximately as shown in orange on the attached Exhibit A.

Subject as to said lands to all matters of public record. E. Gienger hereby grants and conveys to Moisio and Weyerhaeuser, their heirs, successors and assigns, a perpetual non-exclusive easement upon, over and along a right of way over and across the east thirty (30) feet of the E½NE¼ of Section 26, Township 34 South, Range 8 East, W.M., Klamath County, Oregon, located approximately as shown in blue on the attached Exhibit A.

Subject as to said lands to all matters of public record. The parties hereto hereby agree that the rights hereinabove granted shall be subject to the following terms and conditions:

1. The easements are conveyed for the purpose of reconstruction, use and maintenance of a road for the purpose of providing access to or from lands and/or timber now owned or hereafter acquired by the parties hereto.

2. Each party reserves for itself, its heirs, successors and assigns, the right at all times, for any purpose, to cross and recross, at any place on grade or otherwise, and to use said rights of way on land owned by it in a manner that will not unreasonably interfere with the rights granted to the other parties herein.

3. Each party may grant to third parties, upon such terms as it chooses, any or all of the rights reserved by it herein; provided, that use by such party shall be subject to the terms and conditions of this agreement and shall not unreasonably interfere with the rights granted to the other parties herein.

4. When any party is the sole user of said road, or any portion thereof, such party shall maintain that portion of said road so used at its sole expense. However, during periods of time when other parties are using the same portions of said road, maintenance shall be in proportion to each party's use.

For the purpose of this agreement, maintenance is defined as the work normally necessary to preserve and keep the roadway, road structure and road facilities as nearly as possible in their present condition or as hereafter improved.

5. Each party reserves to itself all timber now on or hereafter growing within the rights of way on its said lands.
