ORDINANCE NO. 180

6 WHEREAS, by resolution heretofore adopted, the Common Council
7 of the City of Malin, Oregon, upon it's own investigation and initiation
8 found that it is for the best interest of the public, that a certain
9 alley within the city limits of the City of Malin, being more
10 particularly described as follows, should be vacated:

12 WHEREAS, the Common Council of the City of Malin, Oregon,
13 did by said Resolution fix the hour of 7:30 p.m. of the 8th day of
14 January, 1980, and the City Hall of said City, as the time and place
15 when a public hearing would be held, at which objections and remonstrances
16 made in writing and filed with the City Recorder of said City, or made
17 by the public at said meeting, would be heard and considered; and no
18 objections or remonstrances having been filed or offered at said hearing;
19 and certificate of the City Recorder being filed herein to the effect
20 that all said property to be vacated is a dedicated alley and as such
21 there are no unpaid taxes or city liens against it, and it appearing to
22 the Common council that the market value of property abutting the
23 portion of the alley to be vacated will not be substantially affected
24 by the vacation, now, therefore,

1 THE CITY OF MALIN DOES ORDAIN AS FOLLOWS:

2 Section 1: That a certain portion of the alley, more
3 particularly described as follows: **The East 2' of 5th Street between Blocks**
4 **62 and 63 from the South Boundary of Rosicky Avenue South to the North bound-**
5 **ary of Rush Avenue,**

6 be and it hereby is vacated.

7 Section 2: The City Recorder is hereby directed to file
8 certified copies of this ordinance with the following offices, to-wit:
9 The County Clerk of Klamath County, Oregon, for recording in deed records,
10 the Assessor and Surveyor of said Klamath County, for use in their
11 respective offices.

12 Section 3: The immediate enactment of this Ordinance being
13 necessary for the preservation of the public peace, safety and welfare
14 an emergency is declared to exist and this Ordinance shall be in full
15 force and effect from and after its passage by a three-fourths "aye"
16 and "nay" vote of the Common Council and its approval by the Mayor.


